

## **CardTech Privacy Policy**

This Privacy Policy applies to the collection, use, disclosure and handling of personal information by CardTech and its associated entities (collectively **CardTech, we or us**), including personal information collected via our [www.cardtechpng.com](http://www.cardtechpng.com) website (**Website**).

CardTech is committed to protecting the privacy of individuals and is bound by the *National Privacy Principles* set out in the *Privacy Act 1988* (Commonwealth) (**Act**). We will only collect, use or disclose personal information in accordance with the Act and this Privacy Policy.

Your use of the Website is also subject to the CardTech Website Terms of Use.

### **Collection**

CardTech collects personal information you tell us about yourself and information about your use of our Website (including via cookies). We may also collect personal information about you from another CardTech group entity, from publicly available sources, or in some cases, from third parties. The information may include (but may not be limited to) your name, contact details, Internet Protocol (IP) address, occupation, employer, legal and industry areas of interest, and information relating to your dealings with CardTech and our clients. The purposes for which we collect your information may include providing you with legal services or legal information, or improving our services.

### **Use and disclosure**

CardTech may use or disclose your personal information for the purposes:

- for which it was collected;
- to which you have consented; and
- as otherwise authorised or required by law.

We may also:

- share your personal information amongst CardTech group entities;
- share your personal information with our advisors and consultants, and with third party service providers we use in conducting our business, subject to confidentiality provisions as we deem appropriate (including, without limitation, external photocopying providers, email filtering, virus scanning and other technology services providers, and archival services providers); and
- transfer your personal information to external national or overseas facilities in the course of conducting information and data processing, back up and scanning or for the purposes of obtaining other services from third parties.

### **Information about events, the Website and our services**

We may contact you via email, SMS or other means in order to provide you with updated information about the Website, in relation to events or to provide you with other information about our services. If you do not wish to receive any such information, please contact us as set out below.

### **The information we keep about you**

If you wish to access, correct or update any personal information we may hold about you, please contact us as set out below. However, we may charge for providing access to this information and we may refuse access where the Act allows us to do so.

### **Storage and security of your personal information**

CardTech will take reasonable steps to keep any personal information we hold about you secure. However, except to the extent liability cannot be excluded due to the operation of statute, CardTech excludes all liability (including in negligence) for the consequences of any unauthorised access to your personal information. Please notify us immediately if you become aware of any breach of security.
